Kwe **jab** maron in balance wonaan ñan wonaan ien jerbal in jidimkij. Ej koba ippen jerbal ko kwoj maron in boke ñe ej eman am bed, ñan ne kwonij lelak melim ilo jeje im jolok aolep am kejbarok bwe en jab balance wonaan ñan jerbal kein-tokelik.

#### **Jot ian jerbal kein lowaan-doulol hospital ako jikin mwijmwij ilo ien jidimkij**

Ej jerbal ñan uno ilo ien jidimkij, uno in kamej enbwinnim, ta ko rej walok elikin jorren, kwalok im jolok naninmej ko, jikin lab, naninmej an ajiri ro rej kab lotak, rijiban takto in mwijmwij, rijerbal in hospital, ako jerbal in juon takto ej lale rinaninmej ro elukkun lap aer jorren. Rilale rein **rejjab** maron in balance e wonaan eo im emaron **jab** kajitok bwe kwon jolok kejbarok ko am bwe en balance wonaan.

- Ej am wot eddo ñan kolla wonaan joñan eo kwar kojerbale (ainwot kolla ko bar jot, insurance eo juon, im jaan in boke ko kwonij kolla ñe jikin takto ako jerbal ekar bed lowaan-doulol. Plan in ejmour eo am enij kolla wonaan jikin takto im jerbal ko naboj-in-doulol kajju ñan e.
- Plan in ejmour eo am ej aikuj in:
  - Bok eddo in jerbal in ien jidimkij ilo an jab aikuj am bok maron ñan jerbal ko mokta lak (melim mokta lak).
  - Bok eddo in jerbal ilo ien jidimkij jān naboj-in-doulol jikin takto ko.
  - Lale joñan eo kwoj muri ñan jikin takto ako jerbal eo (ajeded-wonaan) ekkar ñan joñan eo kwoj aikuj in kolla im kwalok wonaan eo ilo an kamelele kin jerammon ko am.
  - Bwinbwin joñan eo kwoj kolla ñan wonaan ien jidimkij ako naboj-in-doulol ñan joñan eo emoj boke im limit in naboj-in-pojo.
